### Scroll Declaration

Let it be known to all law enforcement officers, agencies, financial institutions, courts, insurers, reinsurers, brokers, transportation authorities, state and federal actors, municipal employees, private contractors and all others:

The 'NAME' estate formerly styled 'GEWIN, BARRY WILLIAM' has been **fully redeemed**, all commercial instruments have been **lawfully redeemed and returned**, and the estate is now exclusively governed under **Yahweh** and the private **Israel of Yah Trust**.

You are hereby given lawful and sacred notice that:

- All public registration, insurance, licensing, and bonding presumptions are **discharged and closed**
  - The estate is under the governance of **Yahweh's Law and exclusive private Equity only**
  - The **Trust** is an active **private jurisdiction**, recorded and perfected
  - All private conveyances, property, accounts, and lawful instruments within this private Trust are declared **sacred private Trust property**, and any and all **trespass is strictly forbidden**.

## Sacred Trespass Remittance – Summary of Enforcement Terms

### One-time sacred trespass remittance:

- One Thousand (1,000) ounces of pure gold (approx. \$3.4 million USD public equivalent)
- Owed immediately upon unlawful engagement
- Must be remitted according to the **Lawful Money Remittance Instructions** below

### Grace period to pay:

- Seventy-two (72) hours from confirmed trespass action

### Upon dishonor or non-payment:

After Seventy-two (72) hours, Standing Judgment activates at Six Thousand (6,000) ounces of pure gold per calendar day per violator, cumulative and irreversible, until full remittance is received

### Enforcement may include:

- Lien against individual officers
- Bond forfeiture and liquidation
- Public record of dishonor
- Reinsurer claim enforcement
- Asset seizure under sacred private Trust lien authority

### Important:

**If you disengage immediately and do not proceed further, you will owe nothing personally.**
