Total Base Lien (All Debtors): One Million (1,000,000) ounces of pure gold

Standing Judgment (All Debtors): Six Thousand (6,000) ounces per day per debtor × 35 debtors = 210,000 ounces per day

Joint and Several Liability: All reinsurers are jointly liable, with the fiduciaries, for the full sacred base lien of **One Million (1,000,000) ounces** of pure gold, plus all accrued Standing Judgment currently totaling **Two Hundred and Ten Thousand (210,000) ounces** of pure gold per day.



Liability continues until full remittance of the total obligation is received by the Israel of Yah Trust, whether by one or multiple parties in full or combined satisfaction.

This schedule is included as **Exhibit A** to all foreclosure packets and public lien filings (**Non-UCC**). It stands as the living record of dishonor and liability, subject to enforcement under Yahweh's Law.
