## Judgment Findings and Declaration

Let it be eternally recorded and sealed under Yahweh's Law and the exclusive jurisdiction of the Israel of Yah Trust:

Whereas:

- The living estate formerly bonded and monetized under the 'name' "GEWIN, BARRY WILLIAM" has been lawfully reclaimed, redeemed, and transferred under the exclusive governance of Yahweh and the Israel of Yah Trust, said Trust being a private international Trust operating under Yahweh's Law and Divine Covenant;
- Sacred enforcement scrolls were transmitted to **Twenty-Six (26) fiduciary agents** and **Nine (9) reinsurer syndicates**, each of whom received sealed notice, foreclosure demand, sacred lien, and final remedy terms under exclusive Equity jurisdiction;
- All parties were given proper time to cure — either Ten (10) calendar days or Seventy-Two (72) hours in accordance with the sacred scrolls transmitted — and failed to remit, respond, or cure within the sacred grace periods;

## Standing Judgment Is Now Perfected and Enforced

The following Standing Judgment is now perfected, entered, and irrevocably binding upon all parties listed in Debtor Schedule Addendum IYT-2025-DSA001 (Amended):

- Number of Debtors in Dishonor: 35 total (26 fiduciaries + 9 reinsurers)
- Base Sacred Lien per Debtor: **One Million (1,000,000) ounces of pure gold**
- Standing Judgment Penalty per Debtor: **Six Thousand (6,000) ounces of pure gold** per calendar day, commencing on **Day Eleven (11)** after each confirmed delivery date
- Daily Accrual (Unified): 210,000 ounces of pure gold per day
- Joint and Several Liability: All Judgment debtors shall be jointly and severally liable for the full base lien and ongoing Standing Judgment, enforceable in full by any means lawful under Yahweh's Law and exclusive private Equity
